Overview

In eGovern eRemittance, at the end of the filing process, users see a fee summary of the period displaying, the total, the penalty, the discount, and the interest. Some users may only allow deposits, or have special fees calculated for Late Filings; the details of these payments may be required. In such cases, there is an option to display a detailed summary that includes detailed deposit and fee charges. This option is enabled in the Govern New Administration (GNA). 
User Interface Changes

The **Show Pay Screen with Balance/Fee/Deposit Details** option has been added to the the eRemittance sub-tab of the of the Manage Web Site form in the Govern New Administration (GNA).

Interface Changes - eRemittance (sub-tab)

Present in the GNA is an option in the **Total to Pay** group. To enable the option in the GNA...

1. In the GNA ribbon, select *Application Configurations (group) > Web Configuration (group) > Manage Web Site*.
2. Click to select the eRemittance sub tab.
3. In the *Total to Pay* group, click the **Show Pay Screen with Balance/Fee/Deposit Detail(s)** option.



When the option is selected, and saved in the GNA, the summary screen will be modified, displaying the additional information.

Display of detailed summary (option selected)

Instead of using standard Interest/Penalty calculation, some customer using a special levy to create a fee to be paid. eGovern need to know which detail in AR ('inv') to show as Special fee. It will also need the description associated with the fee.

Details about this option

Users should note that Web site configurations are not year based, but an **A/R Class** is. As a result of this, the information from the actual year is what is used to populate the **Special Fee A/R Class** combo. When a year is copied to the following year through the **Copy to Year** process, users will need to ensure that the same *A/R Class* is used for the next year. If a different *A/R Class*, or no *A/R Class* is used the summary displayed in the eGovern screen will display \$0.00 in the additional fees fields.
